

WAIVER, INDEMNIFICATION, AND RELEASE OF LIABILITY

Release, waive and discharge and covenant not to sue Las Vegas Storm & Hoop City, together with its affiliated clubs, its respective owners, shareholders, administrators, directors, agents, coaches, and other employees or volunteers of Las Vegas Storm & Hoop City, all of whom are hereinafter referred to as "releases", from any and all claims, demands, losses, or damages on account of injury, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by the negligence or other legal fault of the releases or otherwise to the fullest extent permitted by Nevada.

Acknowledge that this Waiver, Indemnification and Release of Liability expressly includes transportation provided, arranged, or paid for by Las Vegas Storm & Hoop City, to and from, or in connection with any activity or event of Las Vegas Storm & Hoop City, in any vehicle, including transportation to and from medical treatment.

Understand and agree that by signing this Agreement To Assume Risks Of Participation In Club Basketball and Waiver, Indemnification and Release Of Liability, I am agreeing to release, indemnify the "releases", described in paragraph 6 above, and hold them harmless from any and all liability, or costs, including but not limited to attorney fees, associated with or arising from my participation.

Understand and agree that if I am signing this Agreement To Assume Risks Of Participation In Club Basketball and Waiver, Indemnification and Release Of Liability on behalf of my minor child, that I will be giving up the same rights for said minor as I would be giving up if I signed this document on my own behalf. I further agree that as a parent(s) or legal guardian(s) of a minor participant under 18 years of age, that I will advise the minor participant regarding the above warnings and conditions and their ramifications, and that I consent to the minor's participation. I hereby consent for said minor to the assumption of risks described in this Agreement.

Understand and agree that this agreement shall be governed by and construed in accordance with the Laws of the State of Nevada. All disputes and matters whatsoever arising under, in connection with, or incident to this agreement shall be litigated, if at all, in and before a court of appropriate jurisdiction located in the State of Nevada, U.S.A. to the exclusion of any other State or Country.

Understand and agree that this agreement may be terminated only by:
Ceasing to participate in any and all activities of Las Vegas Storm & Hoop City. AND
Providing written notice to Las Vegas Storm & Hoop City. OR
Signing and returning to the Las Vegas Storm & Hoop City. a later version of the waiver, indemnification and release of liability agreement.

TERMINATION BY WRITTEN NOTICE TO LAS VEGAS STORM BASKETBALL & HOOP CITY WILL NOT BE EFFECTIVE UNTIL ACTUAL RECEIPT OF WRITTEN NOTICE BY WBC, INC. TERMINATION WILL NOT RENDER VOID OR INEFFECTIVE THE LEGAL RIGHTS AND PROTECTIONS AFFORDED UNTO WBC, INC. FOR INCIDENTS (CLAIMS, DAMAGES, INJURIES, ETC.) OCCURRING, OR ALLEGED TO HAVE OCCURRED, PRIOR TO THE DATE OF TERMINATION.

I have read the above Agreement To Assume Risks Of Participation In Club Basketball and Waiver, Indemnification, and Release Of Liability Agreement and understand that I give up substantial rights by signing it and knowing this, sign it voluntarily. I further agree that no oral representations, statements, or inducements, apart from the above agreement have been made. I agree that this agreement is intended to be as broad and inclusive as is permitted by law and if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue to have full force and effect. I agree to participate knowing the risks and conditions involved and do so entirely upon my own free will. I also acknowledge that if English is not my first language, that I have sought out the assistance of someone competent to translate this form to me. My signature below shall be a declaration that I have so read and understand this Agreement To Assume Risks Of Participation In Club Basketball and Waiver, Indemnification, and Release Of Liability Agreement.

I am the parent/legal guardian of the participant and minor listed below and have the authority to make this agreement on behalf of the participant. A photocopy of this Agreement will have the same effect as the original.

REFUND POLICY.
